Kelly Hayes-Raitt is an activist and author who has worked tirelessly for the past three decades on issues of civil and human rights, as well as for the protection of the environment. As a passionate and effective advocate, she has appeared on more than

500 radio and television public affairs shows including PBS "News Hour with Jim Lehrer," CBS "This Morning," CNN "Financial News," and CNN "Moneyline."

Five weeks before the US-led invasion of Iraq, Ms. Hayes-Raitt was visiting with a women's delegation. The Iraqis touched her deeply and she returned to provide on-air commentaries to National Public Radio. This experience also led to her current book project, "Violating Sanctions: An American Woman's Listening Tour Through the Axis of Evil".

At the Cal Turner Program Breakfast, Kelly will take up the question of effective leadership, drawing on her many years of experience as an activist, political consultant and writer. Please join us for what promises to be an interesting and provocative presentation and discussion

- Designing contracts with outside partner agencies
- Creating annual budget
- Preparing annual donor reports
- Preparing annual tax information
- Reviewing student reports
- Researching trends in education
